# **REQUESTING A RECAST OF YOUR MORTGAGE**

Dear Homeowner(s):

If you've recently received a large sum of cash, such as proceeds of a home sale or an inheritance, you may be able to make a substantial payment towards your principal balance, which could lower your monthly payments. This is called a recast. GMFS Mortgage LLC, serviced by Shellpoint ("GMFS") is pleased to offer this service to qualifying customers. Please review the questions and answers below regarding eligibility and costs associated with the recast process.

### What types of mortgages are eligible for a recast?

Conventional fixed-rate loans may qualify for recast. Additionally, recast may be available for loans that are owned by Federal National Mortgage Association ("Fannie Mae"), Federal Home Loan Mortgage Corporation ("Freddie Mac"), and other select investors. Adjustable-rate ("ARM") loans may qualify as long as they are 1) not currently in an interest-only period, and 2) not Government-insured loans such as FHA, VA and USDA.

Loans that carry FHA are not eligible, however, loans carrying Private Mortgage Insurance (PMI) can be considered eligible only if the curtail to principal is enough to simultaneously cancel the PMI during the Recast (PMI will **not** automatically cancel during the recast. A formal request to cancel PMI will need to be submitted once recast is completed.)

#### What options does a recast offer me?

A recast is a simple procedure that lowers your monthly loan payments. However, if you want to change the term of your loan or convert an ARM to a fixed rate, you will need to refinance your loan.

### Will my loan's interest rate change as a result of a recast?

No, the interest rate will not change.

### How much cash do I need to be considered for a recast?

Generally, you will be required to submit a minimum of \$5,000.00. This sum is called a principal curtailment.

### How much does it cost to recast a mortgage with GMFS?

GMFS charges \$250.00 to cover all administrative fees, if applicable, based on state guidelines. GMFS will need to receive the payment prior to performing the recast, if applicable.

### How long will it take to finalize the recast and lower my monthly payments?

Generally, a recast will take around 60 days to finalize.

### I have an escrow account for my mortgage. Will a recast affect the escrow?

No. Escrow accounts are only affected by changes in tax rates or insurance premiums.

#### How do I request a recast?

Recast requests can be made in writing or by contacting Customer Care at 866-392-1860. You will need to sign the attached **Recast Authorization Form** and return it to GMFS with your principal curtailment payment of at least \$5,000.00. This payment can be made via bank wire, by check, on our website gmfsservicing.com, or over the phone with a Customer Care representative. Please see below for additional payment instructions.
