This is known as value acceptance or automated collateral valuation. This means that there is sufficient market data to assess a reasonable value for the property without obtaining a full appraisal. The estimated value will be used to determine the loan-to-value ratio and to make a credit decision on the loan. This estimate is not representative of the true market value of the property that would be assessed by a certified/licensed appraiser. In some instances, a Property Data Collector may schedule an appointment with you and take photos of the property. These photos are not used to prepare an appraisal. Rather, these photos are used to verify the condition of the property.
